





The Windows 8 "Power Up" Game App competition Terms & Conditions

- 1. **ELIGIBILITY**. This promotion is open to any person resident in the United Kingdom who is registered to publish Apps on the UK Windows 8 Store and is eighteen (18) years of age or older at the time of entry. Employees of BAFTA or Microsoft or their affiliates, subsidiaries, advertising or promotion agencies are not eligible, nor are members of these employees' families (defined as parents, children, siblings, spouse and life partners).
- 2. **AN ENTRANT**. An entrant may be an individual or a team. If entering as a team, a Team Captain must be elected. A maximum of 5 people are permitted in each team including the Team Captain. The individual, or if a team, the majority of the team, must be based in Wales, either by way of permanent residence or by way of attendance at a Welsh Further Education or Higher Education establishment.
- 3. **ENTRY**. All entrants must register their intention to enter the competition by completing the registration form on the BAFTA Cymru website www.bafta.org/wales. Entry to the competition is then dependent on the successful self-publication of your Windows 8 game app to the Windows 8 Store by 18:00 Sunday 12 January 2014. Upon successful publication please send an email to Andrew@microsoft.com confirming the following: your name, your studio name, your contact details, the name of your game app and a forward of the Store Certification email for the game app. There is no limit to the number of game apps you can submit to the Windows 8 or Windows Phone 8 Store for the competition.

Please be aware that there is an annual registration fee required to register as a publisher of Apps on the Windows 8 and Windows Phone 8 Store. You will need to be registered to successfully submit a game app.

To the extent that entry requires the submission of user-generated content such as photos, videos, music, artwork, essays, etc., entrants warrant that their entry is their original work, has not been copied from others, and does not violate the privacy, intellectual property rights or other rights of any other person or entity.

Entries will be ineligible for the prize draw if they:

- are incomplete;
- violate the rights of any other person or entity; or
- are received outside of the Promotion Period set out below.

All valid entries will be initially reviewed by a BAFTA Cymru / Microsoft panel of judges and a shortlist of 10 games will be submitted to the final judging panel of BAFTA Cymru, Microsoft and independent judges. The judging criteria are detailed below along with the percentage of points applicable to each element. Total score per game is a potential 100 points out of 100 points.

The final judging decision will be made by Monday 27 January 2014.

Judging will be based on the criteria below and will be scored out of 10 for each category:

- Innovation & Feasibility 33%
- Solution Design, Architecture & Functionality 33%
- Utility & Design 34%

A maximum of one prize per eligible entry is allowed. Winners will be notified by telephone and email to the contact details provided by the potential winner by Wednesday 29 January 2014. If a potential winner has not confirmed receipt of the notification within FORTY EIGHT (48) hours after the first attempt, an alternative winner will be selected on the same basis as described above (either at random for prize draws or according to the same judging criteria for competitions). Winners may be asked to provide identification proving their eligibility before they are entitled to receive the prize. Winners may be required to participate in further publicity or advertising.
